

### AMP Fall 2020 Outreach: Develop Strategies

#### Overview

The Alexandria Mobility Plan (AMP), a strategic update to the 2008 Transportation Master Plan, will guide decision-making and outline priority strategies to ensure that transportation in the City continues to serve the needs of residents, businesses, and visitors as the region grows and new technology impacts the ways we get around.

Through past outreach, we heard about your priorities to reduce congestion and cut-through traffic, improve transit, and make streets safer for all Alexandrians. This round of engagement seeks input before the complete draft plan is released in early 2021.



**Strategies** are specific and achievable initiatives or projects that support the accomplishment of the plan's vision and guiding principles and the City's mobility goals and policies.

# Draft strategies address a range of needs identified through public outreach and data:

#### If you are interested in **Reduced Congestion**, then you might like these draft strategies:

- Develop a traffic mitigation program to improve travel on local streets
- Adopt a smart signal technology to improve traffic flow
- Add more frequent and efficient bus service to attract new ridership reducing the number of cars on the road
- · Pursue regional partnerships to manage congestion
- Advance targeted programs, incentives, and education to encourage people to travel by means other than driving alone

## If you are interested in **Better Options for Getting Around**, then you might like these draft strategies:

- Identify mobility hubs in strategic locations to connect public transit with other multimodal and shared transportation options
- Expand ferry options for better access by water to different destinations
- Establish a pilot program that provides a consistent process for testing new options
- Prioritize demands for the curb (transit, bike parking, drop off, parking, etc)
- · Implement Alexandria Transit Vision Plan and Transitway corridors
- Continue to implement the 2016 Pedestrian and Bicycle Chapter priorities

# If you are interested in *Transportation Equity*, then you might like these draft strategies:

- Review of fare policy to ensure access for people of all means
- Use data to ensure that resources are distributed equitably
- Add more frequent, all-day bus service bus service Citywide, but particularly in the West End
- Establish parking policies to support housing affordability and ensure greater access for persons with limited mobility
